Rasheed's Achievements During The Year 2019



- Rasheed participated in the activities of the Civil Society Forum in preparation for the Fourth Arab Economic and Social Development Summit in Beirut, Lebanon. Our participation focused on several issues affecting the Arab citizen, most notably the issues of raising the standard of living, poverty, food security, environment, trade, economy, and human rights.



- The Global Change Forum was held in the United Kingdom, to discuss issues such as conflict prevention, state-building, defense and security, the global economy, human rights, and good governance, multilateral institutions, sustainable development, and the environment.



- Enhancing the role of women in the fight against corruption and clarifying the importance of their role in reporting violations, through a video containing messages directed by the staff of "Rasheed". That was launched in conjunction with International Women's Day.



- Holding a training program for several employees of the Integrity and Anti-Corruption Commission on the complaints management system for two days, as part of the USAID-funded Integrity Action Project. On the investigation, investigation of privacy and complaints of corruption and other related matters. International conventions on the right to complain, and the criteria for distinguishing between a complaint in good faith and a malicious complaint.



- Rasheed participated in the workshop held by the Ministry of Communications and Information Technology in cooperation with the Ministry of Planning and International Cooperation and the United Nations Economic and Social Commission for Western Asia (ESCWA) to promote the concept and application of open government data to achieve transparency, integrity and accountability and raise the efficiency of government performance, and its importance and impact on the economic and developmental level. Rasheed's participation came as part of the Compliance Task Force # 2 in the fourth National Plan for the Transparent Government Partnership Initiative 2018-2020.



- Rasheed's team participated in the training of students of the "Watch" initiative at the University of Jordan on the mechanisms of monitoring the elections of the Students Union of the University of Jordan .

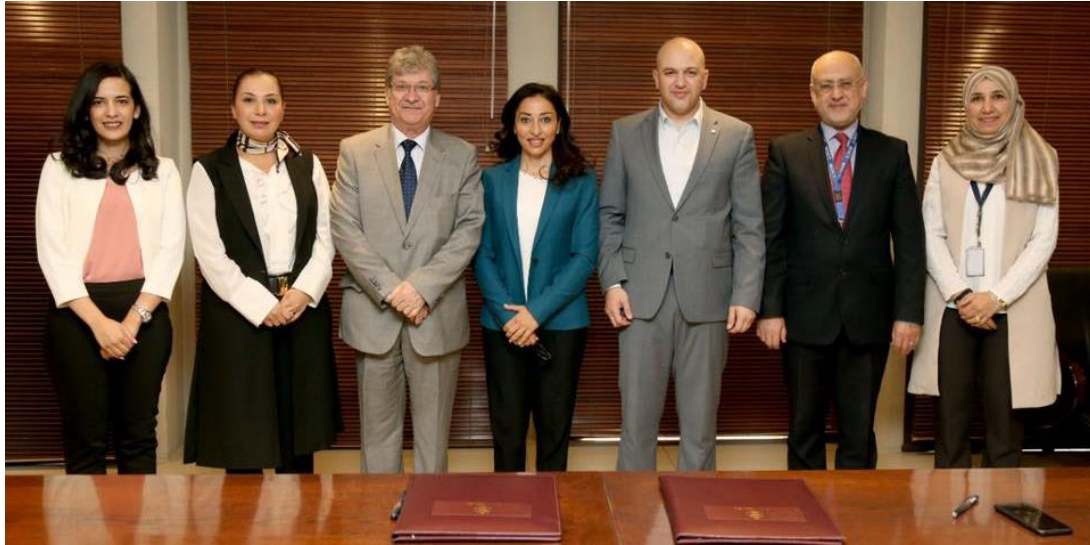


- ✚ The Rasheed Foundation met with a group of civil society organizations in a workshop to discuss the foundations and tools of social accountability and ways to use them to activate the control and participatory in the development of financial policies, especially in the public budget, as a first step to establish a "national team to support the transparency of our country's budget".



- ✚ A Memorandum of Understanding was signed between Rasheed for Integrity and Transparency (Transparency International - Jordan) and the Ministry of Digital Economy and Entrepreneurship to enhance cooperation and coordination in the field of transparent governments in implementation of the obligations of Jordan in the fourth national plan for transparent government partnership 2018-2020 and implementation of the principles of

open government data policy.



- Rasheed held a training program for a number of employees of the Integrity and Anti-Corruption Commission and the Corporate Control Department by trainers from the Palestinian branch of Transparency International (Coalition for Accountability and Integrity - AMAN) on the "6-step Transparency International Model" to build an integrity and anti-corruption system in the private sector for two days, as part of the USAID-funded Integrity Action Project.



- ✚ Rasheed hosted the Chairman of Transparency International, Delia Rubio, Transparency International's Executive Director, Patricia Morera and a delegation of advisors held meetings of Transparency International's branches in the region with the participation of members of the governing bodies and managers and directors of the executive branches in Tunisia, Palestine, Morocco, Lebanon, Kuwait, Bahrain and Jordan, to analyze the form and complexity of corruption in the next ten years and identify priorities, as well as to develop the vision of international transparency and anti-corruption 2030.



- ✚ The Integrity, Accountability, Transparency and Anti-Corruption Curriculum was launched for private and public universities in Jordan for the first time in coordination with the Ministry of Higher Education. One of the Jordanian academics specialized in this field and was accredited by Yarmouk University as the first Jordanian university to adopt this curriculum. Rasheed's preparation of this curriculum is in support of the implementation of the second objective of the National Integrity and Anti-Corruption Strategy (2017-2025), which aims to

create the national environment to participate in the fight against corruption through national awareness of society, institutions, and individuals.



- ✚ The Rasheed Foundation held a training program for several private companies' employees on the 6-step Transparency International Model for Building an Effective Integrity and Anti-Corruption System in the Private Sector, as part of the USAID-funded Integrity Action Project in cooperation with the Coalition for Accountability and Integrity (AMAN). Transparency International Palestine.



- Rasheed participated in presenting recommendations for the challenges of the internal and external environment governing the work of civil society organizations, as part of the launch of a study of our draft resolution entitled "Strengthening Civil Society Institutions in Jordan to Increase Impact on Democratic Change Processes", implemented by the Center for Strategic Studies.



- Rasheed has launched its new reporting, awareness and educational platform on how to fight corruption.
