## **General Background**





Undoubtedly, the Covid-19 Pandemic has greatly affected all aspects of life, and its impact continues to unfold as the pandemic continues to spread. Second in line among the most affected after the Health Sector, has been the Economic Sector, which comprises the Public Sector, where the general budget is concerned, and the profitable economic sector. Despite all the measures taken by the government, much of these measures did not serve as compensation and were not sufficient to repair the negative repercussions of the Pandemic on the national economy. Robust measures require the development of responsive budgets that are capable of mitigating the downfall and are presented as a package of preventive and remedial steps manifested in the general budget.

If we were to acknowledge the fact that the pandemic took the world by surprise in 2020, the slow and feeble response in developing economic measures to counter the pandemic in 2021 and its protracted impact on future years will no doubt present a huge challenge to all. This paper aims to make a comparison between 2020 and 2021 allocations geared towards the pandemic, as well as to provide an analysis of how far the general budget's measures have been responsive to the pandemic.

An analytical review approach has been used to make the comparison between the 2020 and 2021 budgets, as well as to examine the size of support channeled to "Himmet Watan" as one of the mechanisms adopted by the government to confront the pandemic, and how this continued and influenced 2021.

The endorsed General Budget Law<sup>1</sup> of 2021, Number 5 for 2021, has estimated the 2121 budget deficit at JD1.970 billion, grants included, compared with JD2.1 billion (in budget deficit) in 2020. The total 2021 expenditure (including current and capital expenditure) was estimated at JD9.845 billion, compared with JD9.600 billion in 2020, at an increase of 5%. General revenue in 2021 was estimated at JD7875 billion; 90% of which is local revenue, valued at JD7298 billion, with the remaining amount being external grants<sup>2</sup> at the value of JD577 million. Furthermore, there has been an increase of JD200 million in the public debt interest that will be paid in 2021, reaching JD1.5 billion, compared with JD1.278 of public debt in 2020. This is a considerably big amount, making up one seventh of public expenditure and one fifth of local revenue as estimated in the 2021 general budget draft law.3

The 2021 general budget has seen a decrease in capital investment, standing at JD170 million; which is considered a minute figure that is incapable of confronting the economic challenges resulting from the pandemic. Also, the current expenditure continues to reach unprecedented figures in the general budget, amounting to 88% of the total public expenditure in the 2021 general budget draft law. This is coupled with an increased dependence on internal loans, which reached a growth of JD836 in 2021 compared with 2020.4

An amount of JD165 has been allocated to the item (confronting the Corona Virus)<sup>5</sup> and another JD60 million (in support of affected sectors), while JD85 million was geared to (support public - private sector projects).6

### **One: Ministry of Health Expenditure**





In the general budget law of 2020 and 2021, current and capital public expenditure for the Ministry of Health were as follows, as shown in the table below:

It is evident through the table above that the size of expenditure that has been allocated to the Ministry of Health in 2021 has decreased by JD2.277 million, at a drop of 1%. This indicates that there were no financial measures taken in relation to the health sector's expenditure that correspond with the gravity of the pandemic and its impact on public health rights as well as on the preparedness of health facilities, health professionals, and on securing vaccines in an open manner to control the adverse effects of the pandemic.

The job classification of the public expenditure on public health for 2021, compared with 2020, has dropped to JD23.918.000, re-estimated. Job classification includes: medical products, medical equipment and tools; external clinic services; hospital services; general health services; research and development in the public sector and unclassified health affairs. This affirms that the measures that were taken to control and confront the pandemic have been predominantly traditional in relation to the preparation of the general budget, and that estimated expenditure resulting from the pandemic did not rise up to the level that was required to control or to contribute to mitigating the impact of the pandemic on the health level.

The amounts of money allocated to health treatment in the 2021 budget reached JD75 million, compared with JD90 million in 2020; an indication that illogical estimates were made of the expenditure required in light of the continuing Pandemic as well as the related increase in the infection cases and hospital admissions.

Another sticking point in the 2021 general budget is that an amount of JD1.390 million was allocated to the item (updating and upgrading non-medical equipment and furnishings, whereas the same item had an allocation of JD70 million in 2020. This indicates that the mechanisms and actions taken in the preparation of the general budget do not correspond favorably with the general health situation and with the requirements of confronting the pandemic.<sup>9</sup>

### **Two: Himmet Watan Fund**





Himmet Watan Fund was set up as one of the tools aimed at responding to the repercussions of the pandemic. This Fund continues to face numerous challenges and problems that could be detrimental to transparency, financial disclosure and public information.<sup>10</sup> The advancement made on the Fund's functions, compared with 2020, is evident in the disclosure of the size of donations, which reached JD93 million, whereas the disclosed amount in 2020 was JD29 million<sup>11</sup>. However, there are several challenges that continue to face the Fund, and can be summed up as follows:

- There have been no changes in the procedures that are related to committee formation, in the selection and appointment criteria of those committee members, nor in the dismissal and termination processes (of members of those committees).
- There has not been any dissemination of public audits by an external auditor, as stated in the Fund's establishment bylaws.
- The minutes of meeting of those committees have not been published or made public.
- There has not been any disclosure of the donations that were received by the Fund in 2021, or if there were any donations received this year.
- Himmet Watan Fund's sources of support and revenue as well as donations to this Fund were not listed in the 2021 budget.

The same, as mentioned above, applies to the Health "Sihha" Account, where no information on the amounts or mechanisms related to this account has been disclosed. Sihha Account did not mention the mechanism of donations received during 2021 and no related reports were published. As for donations spent from Himmet Watan, the table below (Table 2)<sup>12</sup> shows the details of expenditure.

The data did not mention any detailed breakdown that explains the amount of spending that was made based on specific needs or data related to the beneficiaries, nor did it show clear and accurate mechanisms of channeling health support, assistance, and relief aid that was directed towards affected parties.

The financial data related to expenditure was listed as a general item.

### **Three: Spending the Corona Virus financial support**

A report was issued on the Ministry of Finance<sup>13</sup> (website) under the title "The Main Advances From Corona Fund to Finance Covid-19 Expenses, comprising the volume of spending during 2020 that was allocated to numerous entities and components, as shown in the table below:

### Based on the table above:

- The sources of donations spent have not been stated; it is not known whether the amounts spent came from loans, or from the treasury or from Himmet Watan.
- There is no streamlining of references and financial data that are presented in a cohesive manner of all the spending and revenues pertaining to the Corona Virus Pandemic.
- There is no streamlined flow of data and information on the spending, revenue and donations during the pandemic.
- The report did not state the amount of spending or the contracts made with relation to the Corona vaccines.
