Volunteer work:

Rania participated in a study visit on Consumer Protection to Copenhagen, Denmark in 2009; the European Commission organized it in Co-operation with the Danish National Consumer Agency. The visit aimed to draft a report including a list of recommendations to GOJ Prime Minister. The Study Visit included an overview of the Danish Consumer Legislations, the Consumer Ombudsman, the cooperation and sharing responsibilities between the Ministry of Economic and Business Affairs and the National Consumer Agency, the Consumer Complaint Board, market Studies, and the membership of the Danish Consumer Council. She drafted and submitted a report highlighting the importance of transparency, whistle blowing, building capacity of citizens on social accountability and the rights of consumers. She recommended that the government and the CSOs and the Consumer Protection Organization in Jordan should work together to help consumers receive better services, and recommended using a consumer complaints portal web base system linked with the government to receive citizens' complains.
