Duties:

The Surveyor is expected to carry out the following duties:

- Create the survey structure, distribution, and analysis methodology.
- Develop and conduct a survey to identify the citizens' public issues regarding social accountability and public participation and openness in ten targeted municipalities. The survey will focus on citizens' perception of the performance of these municipalities, how they perceive their integrity and accountability, if they are responding to their needs, if their voices are heard, what challenges they face in terms of access to information, complaints mechanisms, sharing an idea for a local initiative/projects, etc.
- Analyze the results.
- Submit a detailed comprehensive report after the completion of the survey; it should contain the methodology used for developing the survey, results, feedback, challenges, recommendations, and lessons learned.
