"Nazaha: Support to social accountability and empowering Civil Society for better governance"; is a project funded by the Spanish Development Agency (AECID) and its purpose is to strengthen the capacity and internal governance of CSOs and CBOs to contribute to the improvement of the effectiveness and transparency of the public sector towards the population.

The "Nazaha" program operates within three pillars outputs at enhancing the capabilities, skills and governance of civil society organizations in line with standards of governance, transparency and integrity, specifically:

- 1. Output 1: Social accountability is enhanced based on the establishment of a capacity-building scheme and standards of accountability addressing CSOs and CBOs;
- 2. Output 2: Enhanced social accountability targeting CSOs, CBOs, and youth through the training of their capacities and ability to feed information into policy-making processes;
- 3. Output 3: A participatory approach is tackled at all levels of the development processes to allow transparency and accountability towards youth.

Duties:

The Expert is expected to carry out the following duties:

- Set the criteria of youth selection
- Prepare the methodology of the training and the project execution in general.
- Be part of the committee for interviewing the youth and selecting the best candidates according to the criteria to participate in this project.
- Prepare training material and conduct the training for the youth to enhance their knowledge of the project, and their monitoring role, as well as enhance their creativity to develop digital tools for this purpose.
- Follow up and mentor the successful youth and provide ongoing support to implement their projects.
- Submit a detailed report after each completed task, as follows:
 - 1. After completion of training material development, which contains the methodology, used for developing the training material, recommendations and lessons learned.
 - 2. After completion of the training. The report should contain full details about the training, number of attendees, feedback, recommendation, and lessons learned.
 - 3. Monthly progress report.
 - 4. Yearly progress report.
 - 5. Final Report of the project.
