1. Background

Rasheed for Integrity and Transparency (Transparency International- Jordan) was established at the end of 2013, as a non-profit civil society organization, through a group of activists in public work. "Rasheed" is the only official Transparency International chapter in Jordan. It aims to improve the Jordanian citizen's involvement in anti-corruption activities.

2. About "Nazaha" Project

The "Nazaha" project: "support to social accountability and empowering Civil Society for better governance", is a project funded by the Spanish Development Agency (AECID) and its purpose is to strengthen the capacity and internal governance of CSOs and CBOs to contribute to the improvement of the effectiveness and transparency of the public sector.

3. Scope of the consultancy

The expert will undertake the following tasks:

- Training program design: prepare a comprehensive training program that covers the theoretical and practical aspects related to podcasts from preparation to execution.
- Conduct the training: To enhance participants' skills in preparing and executing podcasts using diverse education methodologies and participatory learning approaches.

The key deliverables for this consultancy include:

- Submission of Training program design "Training material, training action plan"
- Conduct the training.
- Training evaluation: prepare an evaluation tool and criteria to evaluate the participants' performance before and after the training.
- Draft a final report; that includes, but is not limited to, the training progress, the
 development of the participant's knowledge and skills, the outstanding
 participants who should participate in the actual podcasts as moderators,
 challenges faced by the participants, and recommendations for improving
 performance in the future.
