Terms of Reference For Trainer

Job Title: Trainer – Social Accountability and Advocacy Campaigns Training Program

Type of contract: External consultant

Location: Amman

1. Background

Rasheed for Integrity and Transparency / (Transparency International - Jordan) was established at the end of 2013 as a non-profit civil society organization through a group of activists in public work. Rasheed (TI - JO) is the only official point of contact representing Transparency International in Jordan. It aims to improve the Jordanian citizen's involvement in anti-corruption activities.

2. Training Program Objective

The project aims to empower youth aged 18 to 30 by offering a 5-day training program focused on **Social Accountability and Advocacy Campaigns to Prevent Crises.**

Note: Both the trainer's guide and the trainee's handbook have been pre-prepared.

3. Scope of the consultancy

The Trainer is expected to provide 5 days of training on the topic mentioned above, and specifically, the Trainer will undertake the following tasks:

- Consult with Rasheed and the project team to clarify objectives, processes, and expected outcomes.
- Collaborate with Rasheed and the project team to clarify the training objectives, processes, and desired outcomes.
- Review the pre-prepared trainer and trainee manuals.
- Develop a detailed agenda, pre- and post-assessments, and participant evaluation forms aligned with the training manual.



- Assess participant's performance during the training and guide them in organizing peer sessions for others interested in the topic, including providing a concise summary.
- Invite an expert in the training field to join an in-person session, providing insights on the topic and sharing their expertise with participants.
- Conduct the training over 5 days.

4. Deliverables

The key deliverables for this consultancy include:

- Submission of a detailed work plan for the assignment.
- Submission of a comprehensive agenda, pre-and-post assessment tools, and participant evaluation forms.
- Successful delivery of the 5-days training program to the targeted youth.
- Submission of a final comprehensive training report, including a detailed pre- and post-analysis, participants' evaluations of the sessions they conducted, and actionable recommendations.
